#### **COMPLAINT**

XNFS Inc; XN Capital LLC; and Federal Armament LLC hereby complains against FSAAP LLC, Jaden Smith, Eric Woodhouse, Justin Woodbury, and Daniel Marine, and for their causes of action would show unto the Court as follows:

#### **PARTIES AND JURISDICTION**

- 1. Plaintiff, XNFS Inc. ("XNFS") is a Wyoming corporation which is authorized to do business in the State of Arkansas, which has its principal place of business at 5730 N 6th Street, Fort Smith, AR 72904.
- 2. Plaintiff, XN Capital LLC is a Delaware limited liability company authorized to do business in Arkansas, which has its principal place of business at 5730 N 6<sup>th</sup> Street, Fort Smith, AR 72904.
- 3. Plaintiff, Federal Armament LLC (d/b/a "FedArm") is an Arkansas limited liability company which has its principal place of business at 5730North 6<sup>th</sup> Street, Fort Smith, AR 72903.
- 4. Defendant, FSAAP LLC is an Arkansas limited liability company with a principal address listed with the Arkansas Secretary of State as 5730 North 6<sup>th</sup> Street, Fort Smith, Arkansas. The Arkansas Secretary of State reflects that the agent for service of process for FSAAP LLC resigned, and no replacement agent is named on file. The limited liability is owned in part by one

of its Members, Jaden C. Smith, who serves as a Member-Manager of the limited liability company. Effective service of Summons and Complaint on FSAAP LLC may be performed by service upon Jaden C. Smith, who resides and may be served with Summons and Complaint at 181 Heritage Drive, Van Buren, AR 72956. On information and belief, FSAAP is now conduction business at 512 South 3<sup>rd</sup> Street, Van Buren, AR.

- 5. Jaden C. Smith is an individual residing in Crawford County, Arkansas, (181 Heritage Drive, Van Buren, AR 72956) who committed acts of tortious conduct to the harm of FedArm and XNFS Inc. within Sebastian County, Arkansas, as alleged herein.
- 6. **Justin Woodbury** is an individual residing in Sebastian County, Arkansas, who committed acts of tortious conduct to the harm of FedArm and XNFS Inc. within Sebastian County, Arkansas, as alleged herein. Woodbury may be served with summons and complaint at his residence address of 5009 HENDERSON ST., FORT SMITH, AR 72904.
- 7. Winfred Daniel Marine is an individual residing in Sebastian County, Arkansas, who committed acts of tortious conduct to the harm of FedArm and XNFS Inc. within Sebastian County, Arkansas, as alleged herein. Daniel Marine may be served with Summons and Complaint by service at his residence address of 18 NORTHWOOD DRIVE, FORT SMITH, AR 72904.
- 8. Eric Woodhouse is an individual residing in Sebastian County who committed acts of tortious conduct to the harm of FedArm and XNFS Inc. within Sebastian County, Arkansas, as alleged herein. Eric Woodhouse may be served with Summons and Complaint by service at his residence address: 3500 S 74TH ST. Apt. \_\_\_\_, FORT SMITH, AR 72903.
- 9. Jurisdiction and Venue are proper in Sebastian County pursuant to A.C.A. Section 16-60-101 et seq, as Sebastian County is the county in which a substantial part of the events giving rise to

the Plaintiffs causes of action occurred, and Sebastian County is the county where FSAAP LLC had its principal place of business at the time of the events giving rise to the causes of action.

#### **FACT ALLEGATIONS**

- 10. Federal Armament LLC ("FedArm") is a limited liability company which is the owner of machinery and other fixed assets to include fixtures, trade tools, electronics, and other items which are used in the manufacture of guns and ammunition for resale. FedArm received funding for its operations from its Member, XN Capital LLC ("XN Capital").
- 11. FedArm leased the equipment and fixed assets it owns to XNFS, Inc. ("XNFS") for which XNFS pays quarterly asset lease payments. During the relevant time period, XNFS subleased the equipment owned by FedArm to FSAAP, with FSAAP delivering goods at a cost plus basis to fulfill its lease obligations. A list of the equipment owned by FedArm which was located at the premises of 5730 North 6<sup>th</sup> Street, Fort Smith, AR is attached hereto as Exhibit "A" the "FedArm Equipment List". As of the end of 2022, (the last date on which the listed equipment was at the business premises of 5730 North 6<sup>th</sup> Street,) the estimated value of the equipment owned by FedArm was no less than two million dollars.
- 12. XNFS and FSAAP conducted business operations at 5730 North 6<sup>th</sup> Street, Fort Smith, Arkansas, whereby FSAAP utilized the equipment owned by FedArm, and assembled parts for finished goods to be sold and delivered to XNFS in exchange for fees calculated at cost plus (to include taxes and overhead expense). XNFS would sell finished goods assembled by FSAAP to third parties, whereby any regulated goods would be sold by FedArm to the extent required by law. (FSAAP would typically drop-ship finished goods at the direction of XNFS.)
- 13. FSAAP also maintained and insured assets of FedArm under FedArm's strict direction, training, and instruction at the location at 5730 North 6<sup>th</sup> Street, Fort Smith, AR. In exchange,

FedArm would reimburse FSAAP quarterly for all approved overhead not covered in the fees from XNFS, such as rent, insurance, utilities, repairs, and unexpected overhead.

- 14. FedArm or XNFS would order parts and materials from third parties to be provided on consignment to FSAAP for the purpose of assembly of firearms and ammunition. (In other words, title and ownership of all parts, and materials remained with FedArm and/or XNFS while FSAAP performed the service of assembly, import, finishing, inspection, and packing.) XNFS would advance the payment necessary for the purchase of the parts and materials to FSAAP, who would submit the funds it received from XNFS or FedArm for the parts and materials on behalf of XNFS and/or FedArm. If the vendor required, FSAAP would submit its own matching purchase order.
- 15. XNFS owns the trademarks and logos of both FSAAP and FedArm. From inception, FSAAP has an agreement to sell all products through XNFS, as all products are produced from parts consigned and funds advanced by XNFS and/or FedArm.
- 16. FSAAP has an agreement with FedArm to pay for the parts FedArm consigned to FSAAP, which was to pay FedArm upon such time as it sold the finished goods to XNFS for resale.

  (FSAAP was to use the funds received from the sale of finished goods to XNFS to pay FedArm).

  17. XNFS advanced to FSAAP substantial funds for the parts and materials ordered for FSAAP to assemble, for which FSAAP has yet to perform the expected services and deliver to XNFS the finished goods for resale.
- 18. FSAAP has an agreement with XNFS to return to XNFS the parts and inventory for which XNFS funded the purchase (thus consigned). As of February 1, 2023, the value of the inventory of accumulated and owned by XNFS at the business premises in Fort Smith exceeded three million dollars, and the value of inventory in process held in other locations had an estimated

value exceeding an additional million dollars.

- 19. FSAAP has failed to return to FedArm (or pay the market value) of the substantial parts, raw material and inventory consigned to FSAAP. Accordingly, FSAAP has incurred an indebtedness to XNFS for undelivered components, parts, and finished goods. Currently, the amount due to XNFS in undelivered components, parts ad finished goods owed by FSAAP exceeds \$900,000.
- 20. FSAAP would assemble the parts and inventory it manufactured using the equipment leased to it by XNFS.
- 21. FSAAP would be paid a fee for its assembly services equal to the expenses of operation incurred by FSAAP, plus the cost of labor utilized by FSAAP at a calculated hourly rate per FSAAP employee, plus any scrap / losses in assembly, plus any consumed items in assembly, plus any excise taxes paid through FedArm's tax account.
- 22. FedArm ordered and guided the incorporation/formation and organization of FSAAP in 2021 through its counsel, Dailey & Woods PLLC. FSAAP began operations, along with XNFS Inc. on January 1, 2022.
- 23. Jaden Smith was trained for several years while employed by FedArm as a sales manager, until December 31, 2021, when his employment with FedArm was terminated, and he transitioned to FSAAP. Smith was a primary employee and a part owner of FSAAP, although he contributed no capital to the business of FSAAP.
- 24. Eric Woodhouse was trained for several years while employed at FedArm as a purchasing manager, until December 21, 2021, when his employment at FedArm was terminated and he transitioned to FSAAP. Woodhouse was a primary employee and part owner of FSAAP, although he contributed no capital to the business of FSAAP.

- 25. Justin Woodbury was trained while employed by FedArm as a first shift floor manager. On December 31, 2021, his employment at FedArm ended and he transitioned to FSAAP to the same basic role.
- 26. Daniel Marine was trained while employed with FedArm as a shipping and Service manager. He was also listed as a responsible person on the FedArm Federal Firearms License only in an employee capacity. On December 1<sup>st</sup>, 2021, his employment with FedArm ended and he transitioned to FSAAP as shipping and service manager, with no rights over FedArm inventory unless authorized by FedArm's owners.
- 27. The two primary employees, Smith and Woodhouse, were left to run FSAAP operations with their employees and remote offshore workers provided by FedArm and XNFS for the 2022 year. Between Q1 and Q3 of 2022, (January thru September), product demand and margins fell heavily, resulting in less profit at XNFS Inc. which required more products at a faster pace. This, paired with growing overhead at FSAAP, all three companies would fall into a net operating loss in Q3 and Q4 if not resolved.
- 28. In October and November of 2022, the owner of XNFS was required to make changes and cuts to overtime, non-productive hours of FSAAP staff, and personal handling of key employee managers backlog of tasks to increase products and quotas.
- 29. The owner of XNFS informed Smith and Woodhouse of potential further cuts in hours.
- 30. Upon announcing the required changes (cuts in payments to FSAAP), Jaden Smith sent an email requesting to cut his time and hours to part time, so he could take a second job.
- 31. Following Smith's email, (near the end of December 2022) Smith failed to return to work on a Monday and could not be reached. The remote workers assumed Smith quit and took over his role. Smith returned on Tuesday, had a dispute with the remote team and deleted their work and

began to forward sensitive emails without permission. Therefore, the 1<sup>st</sup> shift supervisor, Justin Woodbury was asked to unplug Smith's P.C. and asked him to wait on the production floor for the owner of XNFS to arrive and reassign duties. Smith walked out and did not return.

- 32. Shortly after the exchange described above, Jaden Smith began making accusations against the owner of XNFS, who was later arrested (on February 9, 2023) and physically removed from the business premises in Fort Smith.
- 33. After the owners arrest, Eric Woodhouse was in contact with the Owner of XNFS and the remote worker team in order to keep operations going and would return all sold inventory funds to XNFS such that the Owner of XNFS could retain counsel.
- 34. However, to the contrary, Woodhouse and Smith changed the merchant account to deposit sales and shipping revenue to FSAAP and not XNFS, which was not authorized. In addition, Smith interfered with continual bookkeeping and proper, timely tax payments by the remote workers.
- 35. For at least five weeks, Woodhouse represented to the owner of XNFS that he would return the funds to the account of XNFS, but he never did.
- 36. It was later discovered that Smith and Woodhouse placed their names on the XNFS bank account and stole \$100,000 out of the account. Later, the account was restored to the owner, minus the \$100,000 removed.
- 37. With the owner of XNFS out of the physical building where FSAAP was using the equipment leased to it by XNFS, Jaden Smith, individually, (and as an owner of FSAAP), acting together with Eric Woodhouse, Justin Woodbury and Daniel Marine caused the removal of the equipment and inventory owned by FedArm and XNFS to be unlawfully removed from the building at 5730 North 6<sup>th</sup> Street, Fort Smith, AR *without* the consent or authorization of its

owners, FedArm and XNFS Inc. In other words, Jaden Smith, acting together with Eric Woodhouse, Justin Woodbury and Daniel Marine have converted and stolen the equipment owned by FedArm LLC and inventory owned by XNFS Inc.

- 38. On information and belief, Jaden Smith, acting together with Eric Woodhouse, Justin Woodbury and Daniel Marine, and FSAAP have unlawfully moved the equipment owned by FedArm and XNFS to 512 South 3rd street, Van Buren, AR 72956, to the damage and harm to XNFS Inc.
- 39. Jaden Smith and his associates have used and are utilizing vehicles owned by XNFS and/or FedArm without the consent or authorization of XNFS or FedArm, thereby depriving XNFS and FedArm the use of same.
- 40. In early April of 2023, he owner of XNFS spoke on the phone with Eric Woodhouse, Jaden Smith, with others witnessing the discussions, including Doug Carson Colby Roe with the law firm of Dailey & Woods, PLLC and an attorney with the Rose law firm, whereby Eric Woodhouse and Jaden Smith acknowledged that the equipment and inventory belonged to FedArm and XNFS and that they were not legally permitted to take it and that the equipment and inventory would needed to be returned.
- 41. However, to date the equipment and inventory have not been returned. In fact, the inventory is currently being sold for less than market value online to the harm and further damage of FedArm and XNFS. Smith caused FedArm to move its account with "Gunbroker" to the control of FSAAP, without authorization or consent of the true owner of the account, which is FedArm. (FedArm purchased "ST Auctions", which is an online seller which has been in business over 10 years with an excellent history and rating with the online retain website "Gunbroker".)
- 42. While at FedArm, Eric Woodhouse was given privilege to use the American Express cards

belonging to the owner of XNFS and Fed Arm. The card was used pay the typical \$30,000 per month in FedEx bills to ship product sold through XNFS. When Smith and Woodhouse stole the revenue streams of deposits from XNFS, and moved the revenue to FSAAP, they kept the shipping and freight revenue from the customers, but fraudulently placed the charges on the AMEX cards in the name of the owner of XNFS. (The cards are issued to FedArm – not FSAAP). The owner of XNFS and the AMEX card has been unable to report the fraud as Smith and Woodhouse have the cards and the log ins.

#### **COUNT I- Conversion/ THEFT**

- 43. Plaintiffs incorporate herein by reference the allegations set forth in paragraphs 1 though 42, above, as if set forth in full.
- 44. Jaden Smith, acting together with Justin Woodbury and Daniel Marine wrongfully committed an act dominion and control over the equipment, inventory and property of FedArm and XNFS which resulted in the denial of the rights of FedArm and XNFS in the equipment, inventory and tangible personal property of XNFS, as more particularly described above.
- 45. The unlawful conversion and theft of the property owned by FedArm and XNFS has caused actual damages to FedArm and XNFS, and the deprivation of the property was conducted in such a manner that Jaden Smith, Eric Woodhouse, Justin Woodbury, and Daniel Marine should be held jointly and severally liable to FedArm and XNFS for not only actual damages, but also punitive damages for their wrongful and intentional conduct.
- 46. In this regard, the proper measure of damages owed by Jaden Smith, Eric Woodhouse, Justin Woodbury, and Daniel Marine to FedArm and XNFS is the market value of the property at the time and place of conversion which is believed to be in excess of Five Million dollars.
- 47. In addition, XNFS is entitled to the remedy of replevin of the equipment and property

belonging to XNFS in order to mitigate the damages caused by the Defendants. XNFS is entitled to judgment for the delivery of the property, or for the value thereof in case a delivery cannot be had, and damages for the detention. A.C.A. § 18-60-820.

- 48. FSAAP and/or the individual defendants are selling the inventory and ammunition which is owned by XNFS Inc. and FedArm, at an alarming rate (below market value) through online sales, and are stealing the funds which rightfully belong to XNFS and FedArm.
- 49. Unless a temporary restraining Order or injunction is not immediately imposed, XNFS and FedArm are in immediate danger of irreparable harm given the likelihood that they will be unable to recover money damages arising from the continuing theft of property.

#### **COUNT I I – Breach of Contract**

- 50. Plaintiffs incorporate herein by reference the allegations set forth in paragraphs 1 though 49, above, as if set forth in full.
- 51. XNFS and FSAAP entered into an enforceable contract which may be established through their course of dealing and business records which will show that XNFS leased equipment to FSAAP, and fronted substantial sums to FSAAP for parts and materials which FSAAP was to return to XNFS in the form of assembled and sellable goods at agreed rates and prices.
- 52. FSAAP has used the funds it received from XNFS, and has used the parts, equipment and materials supplied by FedArm, but has failed to deliver the finished goods or inventory to XNFS at the rates and prices for the rental payments and prices for the parts and materials supplied by XNFS.
- 53. FSAAP has accordingly breached the agreement between the parties, causing damages to XNFS and FedArm as a result of the non-payment and non-delivery of the finished goods.
- 54. XNFS seeks damages against FSAAP in an amount to be proven at trial or hearing based

upon the agreement and course of dealing between the parties.

Wherefore, Premises considered, XNFS Inc. and Federal Armament LLC respectfully request that FSAAP LLC, Jaden Smith, Eric Woodhouse, Justin Woodbury, and Daniel Marine be served with Summons and Complaint, and be required to answer and appear herein, and upon trial or hearing that they be found liable for the damages incurred by Federal Armament LLC, and XNFS Inc. for breach of contract, and conversion/theft, and both actual and punitive damages, for the remedy of replevin, or injunctive relief to prevent irreparable harm, for incidental damages arising from the conversion of tangible personal property, for attorney fees and costs, and for such other and further relief to which the Plaintiffs may show themselves justly entitled to receive.
